### Presenting tonight on behalf of Myriad is Katya Lezin:

Katya Lezin is a prolific patient advocate and speaker with a powerful story of not only the trials and tribulations of aggressive hereditary cancers, but also the power and positivity of knowing about her genetic mutation, and preventing cancer in her children.

In 2011, Katya first got that dreaded call, the one that begins with the words, "I don't know how to tell you this..." As a busy mother of three, she felt completely blindsided and unprepared for the emotional and physical toll that an ovarian cancer diagnosis would wreak on her life. Learning that she has the BRCA-1 mutation on the heels of her diagnosis made her feel like the hits just kept on coming. Lezin soon realized that there was much good luck within the realm of bad luck of having cancer. Despite the fact that her cancer journey has included a recurrence, many surgeries, hospitalizations, chemotherapy, and the removal of multiple body parts, she thinks the Big C has brought *more good* than bad into her life.

Katya now travels the country as a patient advocate and survivor, speaking to cancer support groups, medical professionals, and anyone who will listen to her account of the upside of being BRCA-1 positive and being a cancer survivor.
