insurance and continued plummet of reimbursement; Changes to the current "accepted practice" of ordering unnecessary diagnostic procedures to avoid malpractice. The beaurocracy that plagues our system is in dire straights. There is no doubt that each of us is facing more and more uninsured or underinsured patients in our practices than ever before. Our patients grow more and more frustrated at the mountain of paperwork that awaits them at an office visit.

The system that currently exists has turned us into insurance-driven, code-savvy, billing specialists instead of medical practitioners. This is unacceptable for the patient and it's unacceptable for us. For us who first swore to "Do No Harm"... not "Collect the Co-Pay." It is taking the very spirit out of our chosen life's work; the spirit of helping our patients and developing a doctor/patient relationship. Cultivating that relationship is now a rarity, even a luxury that shamefully, none of us can afford.

Do you remember the first patient you encountered in whose life you truly made a difference? Maybe it was during residency. Maybe it was in those first few years of private practice. But remember how it made you feel to know you made a difference in this one life. That feeling was the reason why you went into medicine in the first place.

In this harried system that we practice now, can you tell me, when was the last time you felt that? Again, I say to you: back to basics. And the only way we can get back to the basics of medicine is with our collective voice to our leaders, our lawmakers, and our lobbyists.

I am reaching out to you to reach out to everyone else in our phenomenal profession. With over 1000 doctors on Staten Island, the fact that we have less than half as members is unacceptable. The irony is that most doctors are so busy running on the hamster wheel that our system demands, that they will say they don't have time to commit to this membership. But, we

must convince them that THIS Medical Society will provide them with the voice to finally get off the hamster wheel.

And we can't stop there. We have to educate everyone around us about the perils of the system, as it exists today. Don't forget, our patients are also voters or potential voters. The word "doctor" is from the latin "doctoris," meaning teacher. Educate them.

Our patients are outraged that the name of their insurance carrier is deemed more important than their own name. Share in their outrage. It's not unreasonable to commiserate with them at your disappointment in the system. Let them know that this is not what you envisioned when you went to medical school to help people. Then, tell them how their voice can make a difference. Doctors—teach your patients! Help them help themselves.

We are undoubtedly, members of an exclusive club — members of the world's noblest profession. This comes with enormous responsibility to both each other and the community we serve. It is my wish for the New Year that we begin to chip away at the many challenges we are faced with. It is my goal to increase membership to the Richmond County Medical Society so that we may do that with strong numbers of strong voices.

I'll leave you with a quote from Sir William Osler (pronounced with a long 'o'), a Canadian physician who was one of the four founding professors of Johns Hopkins Hospital.....

"The practice of medicine is an art, not a trade; a calling, not a business; a calling in which your heart will be exercised equally with your head. Often the best part of your work will have nothing to do with potions and powders, but with the exercise of an influence of the strong upon the weak, of the righteous upon the wicked, of the wise upon the foolish."

Medicare Information

Medicare Self-Referral Disclosure Protocol Section 6409(a) of the Affordable Care Act (ACA) ACA requires the Secretary of the Department of Health and Human Services, in cooperation with the Inspector General of the Department of Health and Human Services, to establish a Medicare self-referral disclosure protocol ("SRDP") that sets forth a process to enable providers of services and suppliers to self-disclose actual or potential violations of Section 1877 of the Social Security Act (the Act).

The SRDP requires health care providers of services or suppliers to submit all information necessary for CMS, on behalf of the Secretary, to analyze the actual or potential violation of Section 1877 of the Act. Section 6409(b) of the ACA, gives the Secretary of HHS the authority to reduce the amount due and owing for violations of Section 1877. The SRDP is located on the CMS website at http://www.cms.gov/PhysicianSelfReferral/.

PECOS (Provider Enrollment, Chain and Ownership System)

Currently, National Government Services MEDICARE reports that there are approximately 16,000 practices in New York State that are still not in PECOS. https://pecos.cms.hhs.gov

The following CMS website will let you know if you are in the PECOS file for ordering or referring services under Medicare. It is a list of over **13,000** pages. **So, please DO NOT try to print.** It is a PDF file that you should be able to open and scroll through:

Medicare Ordering and Referring File OR http://www.cms.gov/MedicareProviderSupEnroll/downloads/OrderingReferringReport.pdf

If your NAME and NPI is listed, then you are in the PECOS system and you don't need to read any further.

If your **NAME** and **NPI** is not listed, you need to read further and think about expediting your enrollment in the CMS' PECOS system if you order services for a patient or refer a patient to services under the Medicare Program.

If a physician has not done anything to their Medicare enrollment **since 2003** (i.e. changed a telephone number, moved the practice, changed the place where checks are sent, added or removed health care practitioners from the practice, etc.), then it is most probable that the physician/medical practice is not currently in the PECOS file.

For the Medicare Program, physicians can be:

- Participating (PAR); or
- 2) Non-Participating (Non-par); or
- 3) Out-Out for private contracts with Medicare eligible persons.

In each of these instances, CMS expects physician to have a record in their PECOS System. If a physician is not in PECOS but orders or refers a Medicare patient for care or prescriptions, lab or x-ray, the physician needs to have a record in PECOS. If not, the entity providing the service that was ordered or referred will be denied Medicare benefits.

wants you to know your options: Medicare participation guide

From mid-November through December 31, physicians will have their annual opportunity to review and perhaps change their participation status with the Medicare program. Given the severe Medicare payment disruptions caused this year as Congress established, and then missed, multiple deadlines to stop payment cuts caused by the sustainable growth rate (SGR) formula, the AMA is encouraging physicians to prepare for this opportunity and review their options carefully. To help them choose the direction that is right for their practices, the AMA has developed the "Know your options: Medicare participation guide." This kit contains a detailed explanation of the three available options: participation (PAR), non-participation (non-PAR), and private contracting. It also includes a helpful revenue calculator and various sample materials to help physicians share information with current, new, and prospective patients.

Office of Inspector General increases auditing efforts

In September 2010, the Office of the Inspector General (OIG) of the U.S. Department of Health and Human Services published its 2011 Work Plan, which became effective on Oct. 1, 2010. The Work Plan describes the areas in which the OIG will focus specific audit, investigation, enforcement and compliance activities. The OIG indicated that it will review the extent of potentially inappropriate payments for evaluation and management (E&M) services. The OIG stated that Medicare contractors have noted an increased frequency of medical records with identical documentation across services. Resource can help physician practices prepare The AMA's new Practice Analysis Tools for Healthcare (AMA PATHTM) can help physicians analyze their individual coding and billing practices and compare them with national averages by specialty. Using AMA PATH, a physician can, for example, analyze his or her billing patterns with respect to individual E&M codes and, in so doing, enable the physician to identify and rectify any billing or coding practices or patterns that might draw the attention of the OIG or other governmental agencies. CMS Will Cover Counseling Services to Prevent Tobacco Use

The Medicare Learning Network® (MLN) has released *MLN Matters Article #MM7133* to inform providers that the Centers for Medicare & Medicaid Services (CMS) will cover counseling services to prevent tobacco use for outpatient and hospitalized beneficiaries. Effective for claims with dates of service on and after August 25, 2010, CMS will cover tobacco cessation counseling for outpatient and hospitalized Medicare beneficiaries 1) who use tobacco, regardless of whether they have signs or symptoms of tobacco-related disease; 2) who are competent and alert at the time that counseling is provided; and 3) whose counseling is furnished by a qualified physician or other Medicare-recognized practitioner. Medicare Improves Access to Preventive Services for 2011;

New Physician Payment Policies Emphasize Role of Primary Care

The Centers for Medicare & Medicaid Services (CMS) issued a final rule with comment period that will implement key provisions in the Affordable Care Act of 2010 that expand preventive services for Medicare beneficiaries, improve payments for primary care services, and promote access to health care services in rural areas. The new policies will apply to payments under the Medicare Physician Fee Schedule (MPFS) for services furnished on or after Jan 1, 2011.

The final rule with comment period implements provisions in the Affordable Care Act that expand beneficiary access to preventive services and, for the first time, provide coverage under the traditional fee-for-service program for an annual wellness visit beginning Jan 1, 2011. This visit augments the benefits of the Initial Preventive Physical Examination (IPPE or "Welcome to Medicare Visit") with an annual visit that allows the physician and patient to develop a personalized prevention plan that considers not only the age-appropriate preventive services generally available to Medicare beneficiaries, but additional services that may be appropriate because of the patient's individual health status. CMS will accept comments on certain aspects of the final rule with comment period until Jan 3, 2011.




